

Release Notes for March 19th, 2025

As part of standard maintenance, the eVitals system will not be available tonight, Wednesday 3/19/2025 from 11PM until 1AM 3/20/2025. Please do not attempt to access the system during this time.

What's changing in eVitals:

- Correspondence Updates - Added new place holders for "Funeral Home Mailing Address" and "Certifier Mailing Address" to populate the address fields with Funeral Home mailing address & Certifier Mailing address. If no mailing address is available, default to the physical address from the case.
- Notification Updates:
 - Funeral Home/Transport Facility types: Emails to go to Funeral Director on Case and Facility.
 - Admin Medical Certifier for Medical Examiner/Coroner: Emails to go to all users under Medical Examiner/Coroner Office.
 - Medical Certifier for all other Facility types: Emails to go to Medical Certifier Only.
- User Request Approval Update – Specific users were impacted when requesting approval. Facilities requested were updated to accept the request.
- Coroner Office now has ability to amend the Medical Examiner Case Number.
- The Medical Examiner referral review rejected status will correctly be retained until the record is registered.
- The user interface has been updated to provide a message when the maximum number of attempts to verify SSN has been achieved and will specify "Unverified".
- Case message Tab is now present for both registered and unregistered cases for Birth Hospitals.
- Facility type updates for UPMC Home Health Care of Pennsylvania and Encompass Health Rehabilitation (Sewickley) - Kennedy Campus.

Local Registrar Specific Changes:

- User will no longer see a "Void Order & Security Paper" button on a completed order.
- *Local Registrar Schedule of Certified Copies Report*, correctly breaks down all skipped numbers in a range into individual lines.
